Notes from ENONAC CAB Meeting

The Eastern New Orleans Neighborhood Advisory Commission held its monthly Commissioners Advisory Board meeting on Tuesday, January 16 at 6:00 pm. The meeting was held at St. Maria Goretti's community center.

Officer Cheryl Diggins is coordinating collection of supplies for shipment to Haiti. Items being collected include personal hygiene items, such as soap, toothpaste, toothbrushes, sanitizer, shaving cream, razors, feminine products, diapers, baby wipes and other baby care supplies. If you would like to donate to this worthy cause, please contact Cheryl at (504) 715-1217. The supplies must be received by February 6.

Representatives from the City of New Orleans and MWH engineering firm provided updates on the Streetscapes project, which includes Read, from I-10 to Dwyer; Lake Forest, from Wright to Bundy; and Crowder, from I-10 to Dwyer. Project options include improvements to sidewalks, walkways, bike paths, vehicular and pedestrian signalization and signage, landscaping and public art. When asked who will maintain these public areas, it was stated that the construction team will provide maintenance for one year. After that, the city's Parks and Parkways department will take over. Construction, which will ultimately cost \$3 million, will begin in August and will take about six months to complete.

Joe Brown Park has six projects, including a bike path to be completed later this year. The pool work is out for bid, and the center is in its design phase. Existing shelters will be updated, and 12 new shelters will be built. Tennis courts will be resurfaced and lights will be added.

According to representatives, the Library is “on schedule” and will be equipped with electronic book readers. Wireless internet access will be available up to one mile from the library with a library card. Since the temporary library opened, it has accommodated about 200 people per day. It contains videos, DVDs, laptops, and books, and is open Monday through Thursday from 10:00 am until 7:00 pm, and on Saturdays from 10:00 am until 5:00 pm.
